


- To improve the capacity of the member organization to advocate for small holder farmer friendly policies and programs that addresses the challenges of their enterprises.

- To promote practices that will assist farmers to adapt to climate change and establish conditions that increase agro ecosystem resilience to stress.




















WORD FROM THE CHAIRPERSON

OVER VIEW OF ACSA

Advocacy Coalition for Sustainable Agriculture (ACSA) is a registered national network of organizations promoting Sustainable Agriculture, Agricultural market development, research and advocacy among Smallholder farmers. This aims at increasing understanding of Member Organizations and small holder farmers in Uganda about the agrarian policy related issues affecting them

The network was established in June 2006 after a series of studies which were conducted by Misereor - Germany on Uganda's agrarian policy environment in relation to smallholder farmers. The studies highlighted that CSOs were playing a big role in the area of food security but with limited knowledge on agrarian policies, Budgeting process and hence inability to guide SHFs in the identified areas. The CSOs then included; Caritas Kampala, Rural Community In Development (RUCID), Caritas Masaka Diocese Development Organization (Caritas MADDO), Caritas Kabale, Hoima Caritas Development Organization (HOCADEO), Agency For Integrated Development (AFIRD), National Organic Agriculture Movement Of Uganda (NOGAMU) and Participatory Ecological Land Use Management (PELUM). Over the years the Coalition has grown under the support of Misereor - Germany from the eight founding institutions (Core group members) to more than 24 national, international and local organizations.

2.1 ACSA Institutional Development

ACSA has a well streamlined board of directors who meet at a quarterly basis to review and approve work plans for the next quarter and give technical advice accordingly. ACSA has a strong secretariat hosted by Caritas Kampala -Nsambya with qualified technical staffs that are very instrumental in the implementation of the project activities on a daily basis.

On this note, three (3) Board meetings have been convened to Plan for ACSA growth and reviewing the ACSA quarterly work plans and sharing the progress from the secretariat as well as reviewing institutional key Governing documents.

STRATEGIC OBJECTIVE 1: BUILD CAPACITY OF ACSA MOS AND FARMERS IN ADVOCACY.

4.1 Key High light 1. Regional Capacity building Workshop

4.1.1 Result Area 1: Exchange visit for experience sharing on best practices of climatic change

The Learning exposure visit was conducted for ACSA MOs hosted by Kazo Mixed farmers` Association -Mubende.

15 participants (MOs Staff and farmers) were supported during the exposure learning visit to Mubende including: Skills Oriented Development Initiative (SODI), AFIRD, Mayuge farmers` Association, Nnina Olugero foundation, Caritas Kampala (SAP) farmers, GAHIAFFEA, EMLI, UYDNET and MMUDFA, MUMPIFA were represented.

Various biodiversity conservation techniques were exhibited from the demonstration gardens of Kazo Farmers` association ecological centre and among individual farmers.

Such techniques include; rain water harvesting techniques both in the wetlands and highlands like the mini-dam, water ditches, drip irrigation, water harvesting tanks, mulching, soil and water conservation, intercropped banana gardens, Vegetable gardens, fish farming, apiary, Livestock among others

The Learning visit provided an opportunity for experience sharing among farmers and MOs staff on different biodiversity conservation techniques and also enabled participants (farmers and MO staff) share and learn new bio diversity conservation measures that can easily be adopted and replicated in their respective organizations and farmer groups.

4.2 Key Highlight: 2 Annual sustainable organic agriculture research and innovation dissemination conference.

4.2.1 Result Area 2: ACSA Conducted, Validated, Launched and disseminated two major studies

ACSA has conducted, published and disseminated two(2) major studies together with their respective policy briefs as follows;

- i "Strengthening local Marketing through Certification". The farming community has always continued to echo limited markets as a major problem faced. The study looked at how certification

The two studies were launched and disseminated during the ten years impact survey dissemination workshop on Sustainable Agriculture was organized by Misereor in conjunction with Sustainable Agriculture programme (SAP) Caritas Kampala and Advocacy coalition for sustainable Agriculture (ACSA).It was held on 22nd September 2016 at JFLIGH Hotel in Makerere Kikoni, Kampala.

The launch attracted over 80 participants comprising of different stakeholders from Line Ministries (MAAIF, MWE), civil society, religious leaders, the private sector, the donor, Individual farmers and the academia.

The primary objective of the workshop was to facilitate mutual learning, and sharing of the ten years impact survey findings among the various stakeholders.

STRATEGIC OBJECTIVE 2. INFLUENCE GOVERNMENT SUPPORT TOWARDS BUILDING THE CAPACITY OF SMALLHOLDER FARMERS IN ENTREPRENEURSHIP SKILLS.

5.1 Key Highlight 1: Sensitisation on Sustainable Climate Change Smart Agriculture, Agroinputs and Agrarian related policies through Radio Programmes

5.1.1 Result Area 1: ACSA has conducted 20 Periodic radio programes on Radio two Kaboozi FM

ACSA conducted radio talkshows and community sharings through interactive sms platform on Agrarian related policies as away of increasing awareness on Counterfeit agro inputs, Climate change and markets and information etc, among communities.

- A total of 20 theme based radio programs have been conducted on Radio two Kaboozi FM. Major themes handled include, land issues, food security, agroprocessing and value addition, Counterfeit agro inputs, Climate change and markets and information
- 15 Presenters have been drawn from, Sim law Seeds, Basic Organics, Officials from Metrology, department MAAIF, UNDA, farmers and technical personnel from ACSA secretariat. And a total of 68 listeners have been able to call back

directly during and after the broadcasts while 157 listeners have sent SMS to online platform appreciating, inquiring for linkages to genuine agro-inputs, drought tolerant and resistant agro inputs, weather forests information, and market linkage between farmers to buyers.

5.2.1 Result Area 2: Support from MOs.

AFIRD sponsored one radio programme. Wecontinue encouraging other MOs utilise the golden opportunity of ACSA slot and sponsor more radio programmes.



We further appeal to MOs who may have similar objectives like those of ACSA to jointly organise some activities with the secretariat to reach wider coverage using minimum resources.

ACSA Radio programmes have continued to contribute the public outcry for reliable technical advice on different farmers' needs.

Model Farmers hosted during Radio talk shows have testified for having widened their visibility beyond the Country in relation to the call backs from the public in demand for services. As a result more people are visiting their farms for knowledge, experience sharing, access to genuine organic agroinputs and market access for their produce. We further appeal to MOs who may have similar objectives like those of ACSA to jointly organise some activities with the secretariat to reach wider coverage using minimum resources.

5.3 Key Highlight 2: Follow up of MOs and Farmer Groups:

5.3. 2 Result Area 3: ACSA Conducted Follow-Up to Eight (8) MOs.

The secretariat undertook eight major follow-up visits to 8 ACSA MOs in different regions.

These include; MMUDFA, AFIRD, UYDNET Mayuge farmers association, Kazo farmers` association, GAHIAFFEA, EMLI, and NOGAMU.

The major outcomes of the follow-up were;

- A platform for sharing and discussion of Regional specific issues affecting different MOs was provided that included a general out cry of continuous dry spells among all MOs visited and the coping mechanism adopted.
- A need for prioritizing of a simple

irrigation which is appropriate, affordable and accessible to smallholder farmers among their groups was identified by all.

- Some MOs visited AFIRD expressed concern for the need for a strong inclusion of Participatory Guarantee System (PGS) in the draft National Organic Policy 2016.
- On the other hand MOs welcomed the idea of organizing some events/activities together with ACSA. Such activities include; Radio talk shows, regional capacity building workshops.
- The secretariat advised MOs to mobilize farmers and Advocacy focal persons to actively
 participate in the Budgeting processes at district levels. This was to enable their regional issues
 prioritized in the district budgets, to ensure that they are reflected in the national budget for
 funding

As a result of Capacity building in advocacy, Some ACSA MOs like Mayuge farmers' association gladly reported to the ACSA team during the follow-up visit that they managed to identify issues were presented during budget that consultation workshop at district level. Through this initiative they managed to acquire support toward a three phase power line for their maize milling machine. At national level, EMLI staff committed themselves to work together with ACSA to popularize climate change policies in the following ways; developing a simplified and pictorial version of National climate change Policy 2015, and translation of the policy in some local languages

5.3 Strategic Objective 3. Smallholder farmers' access to reliable markets strengthened

5.3.1 Key Highlight 1: Conduct annual fair trade campaigns at regional and national levels

5.3.2 Result Area 1

ACSA is mandated to Support farmers and MOs in promoting market access initiatives in the community. However this is only possible if they have easy access to adequate and reliable market information for easy penetration of local markets, regional and international markets. This has been done through introduction of different ways of market information access like, Agricultural shows, Market information SMS, Radio talk shows to share market related information, and capacity building training on market related themes.

ACSA supported MOs to participate in the two major annual national shows, which are national agriculture show at Jinja held in July 2016 and UMA trade fair in Lugogo in October 2016. Nonetheless MOs were encouraged to organize regional exhibitions to access local markets as well as establishing market linkages and networks within their localities. During this period 5 farmers from two ACSA MOs namely; Caritas Kampala-SAP and, MUPIFA were Supported in 2016 to participate in the Annual shows.

- ACSA has been part of the technical Working group undertaking budgeting processes and analysis of the Agriculture sector budget.

- The agriculture sector budget increased from UGX 483 billion in FY2016/17 to UGX 873 billion in FY2017/18

Auditor's Opinion for 2016

Independent Auditor's Report
To the Members of Advocacy Coalition for Sustainable Agriculture (ACSA)

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of "Advocacy Coalition for Sustainable Agriculture (ACSA)" for the year ended 31st December, 2016; which comprise of the Statement of Financial Position, Statement of Comprehensive Income, Statement of Fund Balances, Statement of Cash flows and Notes to the Financial Statements, including a summary of significant accounting policies.

In our opinion, the Financial Statements referred to above, present fairly in all material respects the financial position of ACSA as of 31st December,2016 and of its financial performance and cash flows for the year then ended in accordance with ACSA Articles and Memorandum of Association, the Funding Agreements, Companies Act 2012 and other applicable Generally Accepted Accounting Principles.

Basis for Opinion

We conducted our audit in accordance with the International Standards on Auditing (ISAs). Our responsibilities under those standards and guidelines are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of ACSA in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) together with the ethical requirements that are relevant to our audit of the financial statements in Uganda, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the IESBA Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. There are no key audit matters to communicate in our report.

Responsibilities of Management and Those Charged with Governance for the Financial Statements Management is responsible for the preparation and fair presentation of the financial statements in accordance with the provisions of the Funding Agreement, Generally Acceptable Accounting Principles, ACSA Articles and Memorandum of Association, Companies Act 2012 and other applicable rules and regulations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Figure 1: ACSA Funding trend





Figure 2: Share of ACSA individual activities of the total budget in 2013








Figure 4: Share of ACSA individual activities of the total budget in 2015





Figure 5: Share of ACSA individual activities of the total budget in 2016





